Sir/Madam,

With reference to your application/letter dated 28/06/2005 and subsequent correspondence with the school/inspection in this regard, I am directed to convey the sanction for Composite Provisional Affiliation for Secondary School Examination/Senior School Certificate Examination of the Board for a period of three years w.e.f 01/04/2007 to 31/03/2010.

The school is allowed to introduce the following subjects at Senior Secondary Level during the above period:

CORE: ENGLISH, HINDI

ELECTIVES: HISTORY, POLITICAL SCIENCE, ECONOMICS, ACCOUNTANCY,
GEOGRAPHY, BUSINESS STUDIES, MATHEMATICS

In addition to above, other conditions are as under:

1. "The School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes."
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination/Senior School Certificate Examination and changes made therein from time to time.
3. The school shall appoint only qualified and eligible staff.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
5. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board as may be required.
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
7. The school will provide Laboratories, Library and other facilities as per norms of the Board.
8. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions, pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.



11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
12. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
13. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
15. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
16. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
17. The affiliation Code Number allotted to your school is 1730316. This may please be noted and quoted for any correspondence with the Board.
18. Annual fee @ Rs.4500/- per annum for the year(s) 01.04.2007 to 31.03.2010 (03 yrs.) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.).
19. The school will apply for further Extension of Provisional Affiliation "On Line" at CBSE website www.cbseaff.nic.in together with the prescribed fee of Rs.12,500/- and other essential documents in the preceding year before the expiry of the date.
20. The school will be eligible to open CBSE pattern classes IX/XI w.e.f. 1.4.2007. Accordingly, 1st Batch of class X/XII of the school will be appearing at the CBSE Examination to be held in the year 2009.
21. The school is required to withdraw its affiliation from the State Board as dual affiliation is not permissible. Also State Board class-IX/XI will not be continued w.e.f. 01/04/2007. However for the 2007 & 2008 exam of X/XII the school will sponsor its students for State Board only.
22. The school has to make its own arrangement to sponsor its State Pattern classes which were running prior to the affiliation from the CBSE at respective examination conducted by the State Education Board.
23. Renewal of Registration of Society be ensured.
24. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
25. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
26. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
27. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome developments of the students.
28. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
29. Non-submission of application for extension of Provisional Affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of affiliation bye laws.
30. School will not prepare any student/start any class for any other Board except CBSE from their CBSE affiliated school building/premises.
31. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
32. Pay & Allowances to staff should be revised time to time to bring it at par with that to State Government.
33. The service conditions be strictly followed as per State Education Act and Staff be given appointment/confirmation letters etc. accordingly.
34. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee.

35. The school shall maintain section teacher ratio at least 1:1.5 at each level i.e. Primary (I-V) Secondary (VI-X) and Sr. Secondary (XI-XII).
36. The school has to constitute a committee for protection of woman from sexual harassment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W-P Criminal No. 666-70 of 1992 Vishakha and other State of Rajasthan and others delivered on 13.8.1997.
37. The school shall maintain Reserve Fund in the joint names of the Manager of the school concerned and the Chairman of the Board in the scheduled Bank to the extent indicated below:-

Upto -	500	Students	Rs.60,000/-
501 -	750	"	Rs.80,000/-
751 -	1000	"	Rs.1,00,000/-
Above -	1000	"	Rs. 100/- per student round to nearest thousand.

The interest accruing out of the deposit of reserve fund made by the Institution at the time of affiliation/extension of affiliation be not withdrawn by the management under any circumstances what so ever.

Conditions for Immediate compliance:

1. The school is required to submit a Certificate of land in the revised format duly filled in and attested by Competent Authority.
2. The school is required to remit balance fee of Rs.10,000/-.

Compliance of the above conditions should reach to this office with in three months supported with documentary evidences.


11. 13. The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
14. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
15. Running of **coaching institutions** in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
